Enclosed is a copy of a letter from the Massachusetts State Crime Lab in response to our request of October 30, 2019. Along with the letter, we received a CD which included data in the form of spreadsheets for some of the jurisdictions and protocol testing information.

The letter states that information is provided primarily from about 2000 for Brockton, Fall River, Haverhill, Lawrence, Lynn, Malden, New Bedford, Somerville, Waltham and Worcester, but that the "Department has not completed the spreadsheets for Cambridge, Lowell, Quincy and Springfield."

We have had a quick look at the spreadsheets but have a number of questions as to what the information in the spreadsheet actually represents, especially where the spreadsheet indicates no DNA test was performed. I enclose a spreadsheet for Somerville for your reference.

1. The zipped folder only has pdf documents from 11 out of 15 jurisdictions we sent FOIAs to. Could the lab send documents on the remaining four jurisdictions? (Cambridge, Lowell, Quincy, and Springfield)
2. Does the first part of the Crime Lab Case # refer to the kit collection year? For instance, was this kit (00-00486 in Worcester PD document) collected in 2000?
3. If that is the case, what year do Case Numbers such as C000219 and U000024 refer to?
4. What are the "other" and "unknown" types of cases at the end of documents on Brockton, Fall River, Haverhill, Lynn, Somerville, and Worcester?
5. New Bedford, Newton, and Waltham documents are missing the "Case Type" column. Are all the data in these three documents from "reported sexual assault cases"?
6. If "Case Number" refers to the collection year, the earliest kits in each document are from 2000, with a few exceptions from 1989 and the 1990s, whereas the latest are from 2018. Is it possible for them to send data from 1990-1999, 2019, and 2020 as of April 1st?
7. What is the difference between "Crim kit" and "DNA kit"? A lot of kits show that "Crim kit" was tested, but "DNA kit" was not. What does that mean?
8. Some kits with "Crim kit" tested do not have their "DNA kit" tested, with no explanation in the "DNA reason" column. Why would those kits not be tested? Are they backlogged? Does the lab plan on testing them anytime in the future?

9. Some kits that were not uploaded to CODIS have "Kit produced Profile not suitable/eligible for CODIS" or "Kit produced a Y-STR Profile". However, most kits not uploaded to CODIS don't have any reason. Why were those kits not uploaded to CODIS?
10. What do "Case closed - No response to state inquiry" and "Case closed - Per investigator/ADA" mean? Do they mean before the lab tested the kits, investigator or police department that sent the kit closed the case and requested the kit not to be tested?
11. What does the color code stand for? There are cells that are highlighted in red, pink, yellow, green, and orange in each document.

Thank you for the November 22, 2019 response (“Response”) to my letters requesting information on behalf of the Joyful Heart Foundation regarding fifteen Massachusetts jurisdictions pursuant to the Massachusetts Public Records Law, M. G. L. c. 66 § 10 (the “Public Records Law”). The Response included a CD with information in the form of pdf documents. Joyful Heart requests the following additional information and clarification with regard to the information provided in the CD.

1. The CD includes documents with information relating to eleven of the fifteen jurisdictions. As previously requested, please also provide corresponding documents for the remaining four jurisdictions of Cambridge, Lowell, Quincy, and Springfield.
2. Does the first part of the Crime Lab Case # in the pdf documents refer to the kit collection year? For example, was kit 00-00486 in the Worcester pdf document collected in 2000?
3. If that is the case, what years do Case Numbers such as C000219 and U000024 refer to?
4. What are the types of cases indicated as “other” and “unknown” at the end of the pdf documents for Brockton, Fall River, Haverhill, Lynn, Somerville, and Worcester?
5. The New Bedford, Newton, and Waltham pdf documents are missing the “Case Type” column. Are all the data in these three documents from “reported sexual assault cases”?
6. If “Case Number” in the pdf documents refers to the collection year, the earliest kits in each pdf document are from 2000, with a few exceptions from 1989 and the 1990s, whereas the latest are from 2018. Please also provide the data for kits collected in 1990-1999, 2019, and 2020 as of April 1st.

7. What is the difference between the “Crim kit” and “DNA kit” notation in the pdf documents? Some of the kit information in the pdf documents indicates that “Crim kit” was tested, but “DNA kit” was not. Please explain.
8. The pdf documents show that some kits with “Crim kit” tested do not have their “DNA kit” tested, with no explanation in the “DNA reason” column. Please provide the reason that those kits were not DNA tested. Is this due to a testing backlog? If this is due to a testing backlog, does the Massachusetts State Crime Laboratory plan on testing them anytime in the future?
9. The pdf documents show that some kits were not uploaded to CODIS because “Kit produced Profile not suitable/eligible for CODIS” or “Kit produced a Y-STR Profile”. However, most kits indicated in the pdf documents as not uploaded to CODIS don’t have any explanation listed in the pdf document as to why they were not uploaded to CODIS. Please explain why those kits were not uploaded to CODIS.
10. What do the notations “Case closed - No response to state inquiry” and “Case closed - Per investigator/ADA” indicate? Do these notations mean that before the Massachusetts State Crime Laboratory tested the kits, the investigator or police department that sent the kit closed the case and requested that the kit not be tested?
11. There are cells in each pdf document that are highlighted in red, pink, yellow, green, and orange. What does the color code represent?

This letter is a follow up to your response to request for information from Joyful Heart pursuant to the Massachusetts Public Records Law, M. G. L. c. 66 § 10 (the “Public Records Law”). As you are aware, the Public Records Law provides that the public must have access to public records not specifically exempt from disclosure.

We appreciate your immediate attention to this matter. We understand that the information requested in this letter may not be available within ten (10) business days and in that event, pursuant to Subsection 10(b) of the Public Records Law, we look forward to receiving a written response stating the time reasonably necessary to produce the records or information.

In addition, pursuant to Subsection 10(d) of the Public Records Law, we understand that a fee may be imposed in connection with this request. We would kindly request that you waive any such fee based on the public interest in the requested disclosure. If the fee cannot be waived, please provide an estimate of the fees for the above listed documentation prior to incurring any such fee.

On April 17, 2020, the Massachusetts State Police ("Department") received your correspondence, which seeks clarification of the Department's prior response to your public records request and requests additional materials. Specifically, your request states that you are seeking additional information and explanations for the materials provided to you in the Department's November 22, 2019 response. Your current request states:


1. "The CD includes documents with information relating to eleven of the fifteen jurisdictions. As previously requested, please also provide corresponding documents for the remaining four jurisdictions of Cambridge, Lowell, Quincy, and Springfield.
2. Does the first part of the Crime Lab Case # in the pdf documents refer to the kit collection year? For example, was kit 00-00486 in the Worcester pdf document collected in 2000?
3. If that is the case, what years do Case Numbers such as C000219 and U000024 refer to?
4. What are the types of cases indicated as "other" and "unknown" at the end of the pdf documents for Brockton, Fall River, Haverhill, Lynn, Somerville, and Worcester?
5. The New Bedford, Newton, and Waltham pdf documents are missing the "Case Type" column. Are all the data in these three documents from "reported sexual assault cases"?
6. If "Case Number" in the pdf documents refers to the collection year, the earliest kits in each pdf document are from 2000, with a few exceptions from 1989 and the 1990s, whereas the latest are from 2018. Please also provide the data for kits collected in 1990-1999, 2019, and 2020 as of April 1st.

7. What is the difference between the "Crim kit" and "DNA kit" notation in the pdf documents? Some of the kit information in the pdf documents indicates that "Crim kit" was tested, but "DNA kit" was not. Please explain.
8. The pdf documents show that some kits with "Crim kit" tested do not have their "DNA kit" tested, with no explanation in the "DNA reason" column. Please provide the reason that those kits were not DNA tested. Is this due to a testing backlog? If this is due to a testing backlog, does the Massachusetts State Crime Laboratory plan on testing them anytime in the future?
9. The pdf documents show that some kits were not uploaded to CODIS because "Kit produced Profile not suitable/eligible for CODIS" or "Kit produced a Y-STR Profile". However, most kits indicated in the pdf documents as not uploaded to CODIS don't have any explanation listed in the pdf document as to why they were not uploaded to CODIS. Please explain why those kits were not uploaded to CODIS.
10. What do the notations "Case closed - No response to state inquiry" and "Case closed - Per investigator/ADA" indicate? Do these notations mean that before the Massachusetts State Crime Laboratory tested the kits, the investigator or police department that sent the kit closed the case and requested that the kit not be tested?
11. There are cells in each pdf document that are highlighted in red, pink, yellow, green, and orange. What does the color code represent?"

The Department is currently in the process of reviewing your request and collecting responsive documents. However, I would like to note that the response is going to take additional time due to the state of emergency and the current efforts by every agency to address the COVID-19 pandemic. Nevertheless, the Department will collect and review the available laboratory documents, identify any responsive materials and information and provide a follow-up response to you as soon as practicable. Thank you for your understanding.

If you object to this response, you may appeal to the Supervisor of Records in accordance with M.G.L. c. 66, §10(b) and 950 CMR 32.00. You may also file a civil action in accordance with M.G.L. c. 66, § 10A. Feel free to reach out at any time if you need any other information.

On April 17, 2020, the Massachusetts State Police ("Department") received your correspondence, which seeks clarification of the Department's prior response to your public records request and requests additional materials. Please also provide any readily-available documentation that reflects the total number of sexual assault evidence kits received from the Brockton, Cambridge, Fall River, Haverhill, Lawrence, Lowell, Lynn, Malden, New Bedford, Newton, Quincy, Somerville, Springfield, Waltham, and Worcester Police Departments since they began submitting such kits to the MSPCL, broken down by year of receipt, if possible.
2. Please provide the total number of sexual assault kits received from the Brockton, Cambridge, Fall River, Haverhill, Lawrence, Lowell, Lynn, Malden, New

Bedford, Newton, Quincy, Somerville, Springfield, Waltham, and Worcester Police Department that were analyzed for DNA in the last thirty (30) years, broken down by year. Please also provide any readily-available documentation that reflects the total number of sexual assault evidence kits received from the Brockton, Cambridge, Fall River, Haverhill, Lawrence, Lowell, Lynn, Malden, New Bedford, Newton, Quincy, Somerville, Springfield, Waltham, and Worcester Police Departments since they began submitting such kits to the MSPCL that were analyzed for DNA, broken down by year of either receipt or analysis, if possible.

3. Please provide the total number of sexual assault kits received from the Brockton, Cambridge, Fall River, Haverhill, Lawrence, Lowell, Lynn, Malden, New Bedford, Newton, Quincy, Somerville, Springfield, Waltham, and Worcester Police Departments that were not analyzed in the last thirty (30) years, broken down by year. Please also provide any readily-available documentation that reflects the total number of sexual assault kits received from the Brockton, Cambridge, Fall River, Haverhill, Lawrence, Lowell, Lynn, Malden, New Bedford, Newton, Quincy, Somerville, Springfield, Waltham, and Worcester Police Departments since they began submitting such kits to the MSPCL that were not analyzed further back in time, broken down by year of receipt, if possible.
4. Please provide any documentation, should any exist, explaining why sexual assault kits received from the Brockton, Cambridge, Fall River, Haverhill, Lawrence, Lowell, Lynn, Malden, New Bedford, Newton, Quincy, Somerville, Springfield, Waltham, and Worcester Police Departments were not analyzed for DNA in the last thirty (30) years. If such documentation is readily-available for the entire period since the Brockton, Cambridge, Fall River, Haverhill, Lawrence, Lowell, Lynn, Malden, New Bedford, Newton, Quincy, Somerville, Springfield, Waltham, and Worcester Police Departments began submitting such kits to MSPCL, we request all such readily available documentation.
5. Please provide information on the number of Combined DNA Index Systems (CODIS) hits from sexual assault evidence kits received from the Brockton, Cambridge, Fall River, Haverhill, Lawrence, Lowell, Lynn, Malden, New Bedford, Newton, Quincy, Somerville, Springfield, Waltham, and Worcester Police Departments for the last thirty (30) years, broken down by year. If documentation is readily-available providing the number of CODIS hits from sexual assault evidence kits received from the Brockton, Cambridge, Fall River, Haverhill, Lawrence, Lowell, Lynn, Malden, New Bedford, Newton, Quincy, Somerville, Springfield, Waltham, and Worcester Police Departments since they began submitting such kits to the MSPCL, we request that documentation as well.
6. Please provide documentation and information on the turnaround testing times for sexual assault kits received from the Brockton, Cambridge, Fall River, Haverhill, Lawrence, Lowell, Lynn, Malden, New Bedford, Newton, Quincy, Somerville, Springfield, Waltham, and Worcester Police Departments for analysis. Specifically,

we seek an explanation or documentation on how long it takes, in days, to complete forensic analysis of the sexual assault evidence kits after receiving the kit from the Brockton, Cambridge, Fall River, Haverhill, Lawrence, Lowell, Lynn, Malden, New Bedford, Newton, Quincy, Somerville, Springfield, Waltham, and Worcester Police Department.

7. Please provide any policies and procedures regarding evidence handling, including, but not limited to: turnaround testing times, criteria for testing or not testing a sexual assault evidence kit, what roles determine if a kit is to be tested, and evidence disposal protocols.

Your correspondence dated April 17, 2020, refers to the Department's November 22, 2019, response and seeks additional materials and clarification. The Department considers the portion of your April 17, 2020, correspondence that seeks records a request pursuant to G.L. c. 66, §10, the Massachusetts Public Records Law. As for the remainder of your requests, although the Department considers these questions or general inquiries not subject to the public records law, the Department, in an effort to work with you, responds to your questions/inquiries below. As a reminder, the Public Records Law only applies to records that are already in existence at the time of the request. Consequently, an agency is not required by the Public Records Law to answer questions or general inquiries. Similarly, an agency is not required to create a record that it does not keep in order to respond to a request. 32 Op. Att'y Gen. 157, 165 (May 18, 1977) (custodian is not obliged to create a record in response to a request for information).

The Department responds below to each of the paragraphs in your inquiry individually as follows:

1. "The CD includes documents with information relating to eleven of the fifteen jurisdictions. As previously requested, please also provide corresponding documents for the remaining four jurisdictions of Cambridge, Lowell, Quincy, and Springfield."

When the Department originally responded to your request on November 22, 2019, the Department provided responsive documents for the Brockton, Fall River, Haverhill, Lawrence, Lynn, Malden, New Bedford, Newton, Somerville, Waltham and Worcester Police Departments. The Department created the responsive documents by reviewing the inventories provided by the departments and categorizing the information into the responsive spreadsheets provided. The work to create and complete these spreadsheets is both time and resource consuming. As such, at the time of the November response, the Department had not yet completed the review of the spreadsheets for the Cambridge, Lowell, Quincy and Springfield Police Departments. At this time, the Lowell Police Department and Cambridge Police Department spreadsheets are complete and attached. The other two Departments' spreadsheets are still in progress and are therefore not included in this response.

2. "Does the first part of the Crime Lab Case # in the pdf documents refer to the kit collection year? For example, was kit 00-00486 in the Worcester pdf document collected in 2000?"

The first two numerical digits of a laboratory case number indicate the year the item of evidence was submitted to the laboratory.

3. "If that is the case, what years do Case Numbers such as C000219 and U000024 refer to?"

The first two numerical digits of a laboratory case number, even when they follow a letter, indicate the year the item of evidence was submitted to the laboratory.

4. "What are the types of cases indicated as "other" and "unknown" at the end of the pdf documents for Brockton, Fall River, Haverhill, Lynn, Somerville, and Worcester?"

In addition to reported and unreported sexual assaults, Sexual Assault Evidence Collection Kits may be gathered in other types of cases.

5. "The New Bedford, Newton, and Waltham pdf documents are missing the "Case Type" column. Are all the data in these three documents from "reported sexual assault cases"?"

The Department inadvertently omitted those columns from the spreadsheets that were provided. The enclosed disc contains a redacted copy of those spreadsheets, which includes that information for those three Police Departments.

6. "If "Case Number" in the pdf documents refers to the collection year, the earliest kits in each pdf document are from 2000, with a few exceptions from 1989 and the 1990s, whereas the latest are from 2018. Please also provide the data for kits collected in 1990-1999, 2019, and 2020 as of April 1st."

As noted in the Department's November 22, 2019, response, the information you were seeking in your initial request was not readily available in a single document dating back 30 years and categorized by year. The Department provided you with the aforementioned spreadsheets that the laboratory generated for its own internal purposes. Notably, these are reference documents used by laboratory staff. These spreadsheets include some information, but are not all inclusive of cases prior to 2000. Additionally, these reference documents were initiated in 2018 to provide specific information for the laboratory and represent a snapshot of the information available at that point in time. Information for cases submitted subsequently is not included in these spreadsheets and would require the laboratory to create additional documents.

7. "What is the difference between the "Crim kit" and "DNA kit" notation in the pdf documents? Some of the kit information in the pdf documents indicates that "Crim kit" was tested, but "DNA kit" was not. Please explain."

Excellence In Service Through Quality Forensic Science

A "Crim kit" refers to the criminalistics examination of a sexual assault kit by the laboratory's criminalistics unit and "DNA kit" refers to the DNA analysis of sexual assault kit items by the laboratory's DNA unit."

8. "The pdf documents show that some kits with "Crim kit" tested do not have their "DNA kit" tested, with no explanation in the "DNA reason" column. Please provide the reason that those kits were not DNA tested. Is this due to a testing backlog? If this is due to a testing backlog, does the Massachusetts State Crime Laboratory plan on testing them anytime in the future?"

There are a host of potential reasons that DNA testing may not have been completed in any given case or investigation, including the nature of the evidence, the absence of testable material, and the determinations made by law enforcement and prosecuting agencies. If the reason is not noted on the spreadsheets that were provided to you, the only way to gather this information is by pulling each of those cases and reviewing the individual case file. Notwithstanding, the Department is reviewing cases where DNA testing was not performed; in consultation with the investigating agencies and prosecuting offices so that determinations can then be made as to what items may benefit from further testing. Kits did not and do not go untested because of lab capacity.

9. "The pdf documents show that some kits were not uploaded to CODIS because "Kit produced Profile not suitable/eligible for CODIS" or "Kit produced a Y-STR Profile". However, most kits indicated in the pdf documents as not uploaded to CODIS don't have any explanation listed in the pdf document as to why they were not uploaded to CODIS. Please explain why those kits were not uploaded to CODIS."

Generally speaking, MSPCL uploads every eligible profile to CODIS. If the kit cannot be tested or if testing does not yield an eligible profile, then it cannot be uploaded to CODIS. If the reason is not noted on the spreadsheets that were provided to you, the only way to gather this information is by pulling each of those cases and reviewing the individual case file.

10. "What do the notations "Case closed - No response to state inquiry" and "Case closed - Per investigator/ADA" indicate? Do these notations mean that before the Massachusetts State Crime Laboratory tested the kits, the investigator or police department that sent the kit closed the case and requested that the kit not be tested?"

At the time these documents were created, and consistent with its mission to assist in the accurate investigation of criminal conduct, the laboratory relied upon information from police and prosecutors when assessing any form of evidence for DNA testing. The former notation indicates that the case was closed because the laboratory did not receive from the investigating agency or prosecutor a response to the laboratory's inquiry relative to the status of the case and what/if testing was needed. The latter notation indicates that the case is closed based on information provided by the

investigating agency or prosecutor. As you are aware, under M.G.L. c. 41, § 97B½, the laboratory currently tests all kits it receives.

11. "There are cells in each pdf document that are highlighted in red, pink, yellow, green, and orange. What does the color code represent?"


Although colors appear on the spreadsheets, there is no color coding system.

Please note that the additional materials being provided have been redacted to remove all material that is subject to the exemptions explicitly cited in the Public Records Law. G.L. c.66, §10; G.L. c. 4, §7 (26). Pursuant to the law, the Department has withheld materials that are exempted from disclosure by necessary implication of a statute pursuant to G.L. c. 4, § 7 (26)(a), as well as information that falls within the investigatory exemption of G.L. c. 4, § 7 (26)(f), privacy exemption pursuant to G.L. c. 4, § 7 (26)(c), and medical exemption pursuant to G.L. c. 4, § 7 (26)(c). The Department has specifically redacted the information in the column entitled "Notes" as it contained medical content, private materials such as references to private and sexual concepts and parts of the anatomy, and information that is protected by statute, such as DNA information, information related to a juvenile and Criminal Offender Record Information. The Department has also removed the information in the column for the Department Case Number and the column for the Kit Number columns from the spreadsheet to maintain privacy of the victims in the cases.

If you object to this response, you may appeal to the Supervisor of Records in accordance with M.G.L. c. 66, §10(b) and 950 CMR 32.00. You may also file a civil action in accordance with M.G.L. c. 66, § 10A.
